As more buildings become certified green buildings and strive to reduce their environmental footprint, there is an industry need for vocational training that supports the operational and maintenance practices of these green buildings.

## Why is green cleaning important to SEIU?

#### background

Across the Midwest, many Local 1 members live in neighborhoods affected by air pollution, poor water quality, extreme heat and other impacts of climate change.

In Chicago, buildings create nearly **70**% of the city's total greenhouse gas emissions.

taking action

To address these issues, Local 1's Chicago members launched the GJEP at the Merchandise Mart and 321 N Clark in Chicago beginning January 2023.



#### **Overview**



Program curriculum focuses on general education and practice of sustainability to help members realize their own role in the sustainability of their building. From this, members take ownership over energy conservation, waste diversion and recycling, health and safety, water conservation etc.



#### **Energy Savings**

On average, GJEP buildings use 5.6% less energy than non-GJEP buildings (seedLA)

#### **Water Savings**

76% of GJEP buildings saw a decrease in energy & water usage

#### **LEED Certification**

Buildings that complete GJEP receive additional credits toward LEED status

### Tenant and Worker Health

Tenants & workers face reduced exposure to harmful chemicals

#### Retention

Workers receive additional training to build skills & professionalism

#### **Union Difference**

The GJEP curriculum is SEIU proprietary info and is therefore not available to nonunion contractors





## Impact of the GJEP





#### **Janitors**

janitors use the knowledge obtained from the training to influence their community, family members and coworkers to implement green, efficient and sustainable practices.



#### **Tenants**

tenants also learn sustainability practices such as recycling that they can employ in their own homes



#### **Guests & Public**

tenants and guest also benefit from reduced exposure to harmful chemicals in buildings where GJEP products & practices are used

#### student feedback

"When I first started working as a janitor I honestly thought I wasn't that important to the company since I was just a person who cleans after tenants.

Now I can say that we are very important because not only [do] we clean but we also see, hear, and smell things that happened here and we have to report it to our supervisors.

#### **Structure**

- 30 hour program over 15 weeks
- 6 modules, 2 exams
- Usually the first 2 hours of a shift, once a week. If 2x a week, timeline shortens to an 8 week program
- Training takes place on site; high participation

#### **GJEP in your Building: Process**



#### Setup

Get go ahead from building owner, property mgr, tenants, contractor



#### Launch

Finalize schedule, hire & train trainer(s), sign contracts



#### **Program**

Run program onsite, union reps attend to proactively assist



#### **Graduation**

Janitors receive
USGBC green
cert, bldg applies
credits toward
LEED status

### Will I get paid for this training?

Yes, your company is paying you your normal rate of pay



### Do I have to attend this training?

Yes, this training is mandatory



#### How will I get my work done if I'm missing 2 hours?

We work with the building & trainers to ID days that are less busy because you are not expected to complete 8hrs of work in 6hrs



#### What is this program about?

The training is a way to provide all janitors with new skills to reduce waste from buildings, and in the process, to get building owners to invest more money into janitors wages, benefits, and trainings


